Privacy policy

Please read this privacy policy and our general terms and conditions carefully before using this website.

Wolf Laboratories collects certain information or data about you when you sign up to www.wolflabs.co.uk, or contact us via telephone or email.

We collect:

- Questions, queries or feedback you leave, including your email address and telephone number if you contact us via www.wolflabs.co.uk, by phone, by email or by placing an order
- Your email address when you sign up to our website or contact us using a company email address to receive our marketing emails, and information on how you use our emails - for example whether you open them and which links you click on
- Information on how you use the site, using cookies
- The data entered when you request a quote, place an order, or open an account via www.wolflabs.co.uk

This data can only be viewed by authorised people in Wolf Laboratories to:

- Improve the site by monitoring how you use it
- Gather feedback to improve our services, for example our email alerts
- Respond to any requests you send us, if you've asked us to
- Send marketing emails to users who have not opted out
- Allow you to access special pricing on our website and make transactions

Where your data is stored

- We store your data on secure servers in the European Economic Area (EEA).

Keeping your data secure

- We implement a variety of security measures to maintain the safety of your personal information when you place an order or enter, submit, or access your personal information.
- We offer the use of a secure server. All supplied sensitive/credit information is transmitted via Secure Socket Layer (SSL) technology and then encrypted into our Payment gateway provider's database only accessible to those authorised with special access rights to such systems, who are required to keep the information confidential.
- We are responsible for the information that we collect and committed to ensuring that your information is secure. In order to prevent unauthorised access or disclosure, we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect online.
- Our Payment Service Provider is Sage Pay – the largest independent payment service provider (PSP) in the UK and Ireland.
- Sage Pay provides a secure payment gateway (Level 1 PCI DSS), processing payments for thousands of online businesses, including ours. It is Sage Pay's utmost priority to ensure that transaction data is handled in a safe and secure way.

- Sage Pay uses a range of secure methods such as fraud screening, IP address blocking and 3D secure. Once on the Sage Pay systems, all sensitive data is secured using the same internationally recognised 256-bit encryption standards.
- Sage Pay is PCI DSS (Payment Card Industry Data Security Standard) compliant to the highest level and maintains regular security audits. They are also regularly audited by the banks and banking authorities to ensure that their systems are impenetrable.
- Sage Pay is an active member of the PCI Security Standards Council (PCI SSC) that defines card industry global regulation.
- In addition, you know that your session is in a secure encrypted environment when you see https:// in the web address, and/or when you see the locked padlock symbol alongside the URL.
- So, when buying through our site you can be sure that you are completely protected.
- We have procedures and security features in place to keep your data secure once we receive it, however please bear in mind that no internet transmission is 100% secure. We can't guarantee the security of your data while it's in transit: any data you send is at your own risk.
- No data is transferred or taken off site on personal devices.

How long will the personal data be stored?

- We will keep your personal data until you make a deletion request or for as long as necessary to provide the services you have requested or for other necessary purposes, such as fulfilling legal obligations, resolving disputes and enforcing our policies.
- Hard copy data is stored securely as per the timeframe outlined by government legislation.

Disclosing your information

- We will not share your information with any other organisations for marketing, market research or commercial purposes, and we don't pass on your details to other websites for this purpose.
- We will only share essential information from your data with our suppliers/manufacturers/subcontractors if deemed absolutely necessary to allow us to respond to any requests you send us.

Your rights
